WHEREAS, there are also four (4) PPA's under 20% Development Fund for Fiscal Year 2019 which are not specifically named and considered as "Generic Terms" that need to be renamed in order to conform with the guidelines set under Budget Operations Manual for the LGU and likewise shall be discontinued;

WHEREAS, there is an increase in the 20% Development Fund share for Fiscal Year 2019 due to the increase of the Internal Revenue Allotment (IRA), thus said amount shall be declared savings and be made available for future use;


WHEREAS, after thorough discussion and deliberation on the merit of the said measure, this honorable body moved to approve the same;
