WHEREAS, the programs, projects and activities in the said plan are deemed highly essential to enable this local government to fully extend to the constituents whatever it can do in times of disaster;


WHEREAS, after thorough discussion and deliberation on the merits of the said measure, this honorable body moved to approve the same;




