WHEREAS, Resolution No. 020 series of 2019 of Barangay Dujali, this municipality was brought to the attention of this august body for appropriate action;

WHEREAS, the said resolution states among others the barangay's request for a permit on cockfighting to be held on April 26, 27 and 28, 2019 in connection with the celebration of Patronal Fiesta of Sr. San Vicente Ferrer;

WHEREAS, Section 8, H. of Municipal Ordinance No. 2017-196, Holding of cockfights, states that "Except as provided in this ordinance, cockfighting shall be allowed only in cockpits, during Sundays and Legal Holidays and during local Fiestas for not more than three days ...", in view of the above, this body grants to Barangay Dujali a 2 days cockfighting on April 26 and 27, 2019; and provided that all provisions of the Revised Municipal Cockfighting Code of 2017 of this municipality shall strictly observed;
