WHEREAS; after thorough scrutiny of the said resolution, and as per Committee Report No. 03, this body found the following findings and recommendations to which it is amenable;

FINDINGS:

1. Barangay Resolution No. 15 series of 2019 contained two subject matters.
2. SK Resolution No. 3 series of 2019 approving Comprehensive Barangay Youth Development Plan for FY 2019-2021;
3. SK Resolution No. 4 series of 2019 both approved the Annual Barangay Youth Investment Plan FY 2019 and Appropriation Ordinance of the Sangguniang Kabataan of New Casay.

RECOMMENDATIONS:



1. SK must prepare and approve Comprehensive Barangay Youth Development Plan (CYBDP).
2. SK must prepare and approve Annual Barangay Youth Investment Plan (ABYIP) based in the CYBDP.
3. SK must prepare and approve the Annual Budget based in the Annual Barangay Youth Investment Plan.
4. Barangay Council must approve a resolution confirming the CYBDP, ABYIP and Annual Budget of the Sangguniang Kabataan of the same barangay.
5. As a general rule, one resolution must contain one subject matter only.
6. Reflect grand total on the annual budget.
7. To pass a resolution returning Barangay Resolution No. 15 s-2019 of Barangay New Casay, Braulio E. Dujali, for proper modification.

WHEREFORE, on motion of Hon. Yasmin V. Campion, duly seconded by the majority of the members, it is hereby;




