EXTENDING THE TIME OF PAYMENT OF BUSINESS TAX OF THIS MUNICIPALITY WITHOUT CHARGES OR PENALTIES UNTIL JANUARY 31, 2019

WHEREAS, pursuant to Section 2C.03, Time of Payment, of Municipal Ordinance No. 2011-128, known as the "Revised Local Revenue Code of the Municipality of Braulio E. Dujali, Davao del Norte" states that; The tax shall be paid once within the first twenty (20) days of January or in quarterly installments within the first twenty (20) days of January, April, July and October of each year. The Sangguniang Bayan may, for a justifiable reason or cause, extend the time for payment of such taxes without surcharges or penalties, but only for a period not exceeding six (6) months;

WHEREAS, as of January 18, 2019, only 75% of the business establishments had renewed business permits this might be due to the fact that the first twenty (20) days of January has only twelve (12) working days, for there were more holidays, Saturdays and Sundays;

WHEREAS, in order to make-up the said non-working days, there is a need to extend the time of payment for the renewal of business permits in order to give more time and to be fair also to the taxpayers;
