**DECLARING THE ENTIRE MUNICIPALITY OF BRAULIO E. DUJALI UNDER THE STATE OF CALAMITY**

Residents were taken out of their homes and brought to evacuation centers, a sight very common to flood prone areas that is extremely heartbreaking and pathetic;

WHEREAS, their present situation is aggravated by the fact that their farms are now underwater, sending them in great pain and loss;

WHEREAS, data coming from the MDRRMC of this municipality shows that affected families are greater in number, infrastructure projects of the government and some other livelihood endeavors had reached hundred thousands if not millions of pesos in damage;

WHEREAS, there is an urgent need to declare State of Calamity in this municipality so that all the necessary responses in terms of food distribution, medical treatment for those who are sick and others can be quickly carried out;


WHEREFORE, on motion of Hon. Ricky T. Delco, duly seconded by all members present, it is hereby;


