RETURNING APPROPRIATION ORDINANCE NO. 1 SERIES OF 2019 OF BARANGAY TANGLAW, BRAULIO E. DUJALI, DAVAO DEL NORTE FOR PROPER MODIFICATION

WHEREAS, Appropriation Ordinance No. 1 series of 2019 embodying the Supplemental Budget No. 1 for Calendar Year 2019 of Barangay Tanglaw was submitted to this Honorable Council and was later endorsed to the Committee on Finance, Budget and Appropriations for review;

WHEREAS, source of fund came from the IRA increase CY 2019 in the amount of P117,709.00 however the Sangguniang Barangay failed to allocate all mandatory obligations such as 5% calamity fund in the amount of **P 5,885.45**, 10% SK fund amounting to **P 11,770.90** and 20% Development Fund amounting to **P 23,541.80**;







