RESOLUTION NO. 2019-14

REQUESTING HON. ALAN R. DUJALI, CONGRESSMAN, 2ND DISTRICT OF DAVAO DEL NORTE TO SPONSOR A BILL RECLASSIFYING THE MUNICIPALITY OF BRAULIO E. DUJALI FROM FOURTH CLASS TO THE SECOND OR FIRST CLASS MUNICIPALITY

WHEREAS, the Municipality of Braulio E. Dujali has an area of 9,100 hectares consisting of Five (5) barangays and has a population of 30,104 based on the 2015 National Statistics Office Survey;

WHEREAS, after careful and thorough review of the financial condition of the Municipality of Braulio E. Dujali for the last four years from 2015-2018, the following facts were established, that this municipality has grown faster than expected in terms of income that it no longer deserve its present classification as a fourth class municipality proven by the following records of its annual income for the last four years (2015-2018);

2015 - P 76,736,250.00
2016 - P 83,595,693.00
2017 - P 92,708,413.00
2018 - P 100,255,451.00

WHEREAS, this is actually a second attempt for the Sangguniang Bayan of Braulio E. Dujali to



come up such request. The former Sangguniang Bayan passed Resolution No. 2016-15 of similar intention, however it was erroneously referred to the Department of Finance, an agency that does not have jurisdiction over reclassification of income of local government units. Consequently, the Department of Finance, only acknowledged receipt of the said resolution with no action other than an advice to have the same be forwarded to the Congress for legislation;

WHEREFORE, on motion of Hon. Restie E. Tabirao, duly seconded all members present, it is hereby;


