GRANTING AUTHORITY TO ATTY. LEAH MARIE MORAL-ROMANO, MUNICIPAL MAYOR TO SIGN IN THE MEMORANDUM OF AGREEMENT BY AND BETWEEN THIS BRAULIO E. DUJALI TEEN TAMBAYAN AND DEPARTMENT OF HEALTH REGION XI FOR THE CASH GRANT OF THE LEVEL II CERTIFICATION ON ADOLESCENT FRIENDLY HEALTH FACILITY AMOUNTING TO THIRTY THOUSAND PESOS (P30,000)

WHEREAS, Letter dated April 05, 2019 of Hon. Atty. Leah Marie Moral-Romano, Municipal Mayor, addressed to Hon. Donna Mae B. Bernadas, Ed.D, Municipal Vice Mayor, thru the Honorable Sangguniang Bayan, requesting the august body to pass a resolution giving authority to the Local Chief Executive on behalf of this Local Government Unit to enter by and between this Braulio E. Dujali Teen Tambayan and Department of Health Region XI in a Memorandum of Agreement for the Cash Grant of the level II Certification on Adolescent Friendly Health Facility awarded last December 10, 2018 amounting to Thirty Thousand Pesos (P 30,000.00), was forwarded to this level and later referred to the committee, for study;

WHEREAS, the contents of the said MOA are as follows;

This Agreement is made and entered into by and between:

The Braulio E. Dujali Teen Tambayan Facility under the Municipal Government of Braulio E. Dujali, a line Local Government Unit of the Republic of the Philippines, composed of 5 Barangays and represented by its Municipal Mayor Hon. Atty. Leah Marie Moral Romano, hereinafter referred to as the **FIRST PARTY**;

And

Department of Health-Region XI, with an office address at Davao City represented by _____, hereinafter referred to as the **SECOND PARTY**;

WITNESSETH:


WHEREAS, Having taken effect on January 17, 2013 in large part due to the strong advocacy of stakeholders and the commitment of Government, Republic Act No. 10354 or "The Responsible Parenthood and Reproductive Health Act of 2012" (RPRH Act) has become the focal point for convergence of multi-sectoral efforts toward the improvement of health outcomes;

WHEREAS, Partnership with local governments as lead implementers of basic health services is central to the success of the RPRH Act, hence the active participation in the process of implementing rules and regulations (IRR) drafting and commitment to implementation thereof by the League of Provinces of the Philippines; the League of Cities of the Philippines; and the League of Municipalities of the Philippines;

WHEREAS, SECTION 3.01 (F) *Civil Society Organizations (CSOs)* refer to non-government organizations (NGOs), People's Organizations (POs), cooperatives, trade unions, professional associations, faith-based organizations, media groups, indigenous peoples movements, foundations, and other citizen's groups which are non-profit and formed primarily for social and economic development to plan and monitor government programs and projects, engage in policy discussions, and actively participate in collaborative activities with the government.

WHEREAS, the Elements of the Responsible Parenthood and Reproductive Health Act of 2012 (Republic Act No. 10354) are Family Planning information and services, maternal, Infant and Child health and nutrition Including breastfeeding, Proscription of Abortion, and management of Abortion complications, **adolescent and youth reproductive health guidance and counseling, prevention, treatment and managements of reproductive tract infections, HIV and AIDS, Elimination of violence against women and children, age development-appropriate education and counseling on Sexuality and RH**, treatment of Breast and reproductive tract cancers and other gynecological conditions and disorders, male responsibility and involvement and men's RH, Prevention treatment and management of infertility and sexual dysfunction, **age development appropriate RH education for adolescents in formal and non-formal educational settings** and mental health aspect of reproductive health care.

WHEREAS, to complement in the provision of age- and development appropriate reproductive health education and services among young people, the **First Party** is implementing a project entitled **Adolscent Health and Youth Development Program"** (Braulio E. Dujali Teen Tambayan Facility) with a funding support from the Local Government Unit of Braluiio E. Dujali of Davao del Norte;



WHEREAS, the **FIRST** and **SECOND PARTIES** agree to support the **First Party** in the implementation of the Project which will serve as a model communities for the implementation of this pilot activity in Region XI; Davao del Norte

NOW THEREFORE, for and in consideration of the foregoing, the **FIRST PARTY**, and **SECOND PARTY** agree as follows:

SECTION I. COMMITMENTS AND RESPONSIBILITIES OF THE PARTIES

A. FIRST PARTY

The **Braulio E. Dujali Teen Tambayan Facility**, under the Municipal Government of Braulio E. Dujali, shall be responsible for providing orientations, technical assistance and support to the **"First Party and Second Party"** and will ensure that the project is well implemented.

The **"First Party"** is responsible of the following:

1. Provide Medical outreach with health information session every month to the target communities, targeting the young key affected population adolescents (10-19 yrs. Old) like Teenage moms.
2. Provide Information Dissemination **"Healthy Young Ones session"** with coordinate with the LGU and BLGU's to the adolescents.
3. Capacitate young volunteers to help for the implementation of the Medical Outreach and Healthy Young Ones session.
4. Coordinate with the 2nd and 3rd parties in the conduct of the different project activities in the pilot areas.
5. Conduct regular joint monitoring and evaluation activities together with the DOH, PHO, MHO, Barangay, Schools in implementation of the project.
6. Prepare and consolidate reports submitted by the project staffs to be forwarded to the **Second and Third Party** for references and other purposes.
7. The project team shall meet quarterly or as need arises to Ensure regular coordination and reporting activity
8. Provide policy support for the implementation of the project;
9. Provide technical assistance to the whole duration of the project.
10. Ensure participation of Public and private partnership.
11. Conduct monitoring and evaluation of the project for quality assurance for Replication;
12. Designate **"Focal Persons"** to assist the Project Team, and to sit as members of the Project TWG for coordination and dissemination of project information;

B. SECOND PARTY

1. Assist and monitor the implementation of **"Adolescent Health and Youth Development Program"** (Adolescent Friendly Health Facility Operations)

- C. **ALL PARTIES** agree that in case of dispute arising from this agreement, the provisions of Book IV, Chapter 14 of Executive Order No. 292 otherwise known as the Administrative Code of the Philippines shall apply;
- D. That the parties have further agreed to comply with this Memorandum of Agreement (MOA) in good faith and the same is further subjected to any law, customs, good morals and public policy that might render any of the provisions of this MOA to be ineffective and without any force as may be declared by any competent court.

SECTION II. EFFECTIVITY

That this MOA shall take effect upon the signing of the parties hereof and shall remain valid until _____ unless otherwise terminated or renewed as may be agreed upon proper notice by the parties;

SECTION III. AMENDMENT OR TERMINATION

Amendment/s to this Agreement shall be subject to the mutual consent of all parties and/or unless either party wishes to terminate the agreement. Written notice to all parties must be made at least thirty days prior to amendment/s or termination of the agreement.
