#### **EXPLANATORY NOTE**

The Municipality of Braulio E. Dujali has been celebrating its foundation day every 8<sup>th</sup> day of March every year. The celebration is pursuant to Municipal Ordinance No. 11 S. 99.

Last year, the 8<sup>th</sup> Sangguniang Bayan had passed a resolution requesting His Excellency President Rodrigo R. Duterte, to declare March 8 as Special Non-Working Holiday in the Municipality of Braulio E. Dujali, Davao del Norte.

However, in reply to said Sangguniang Bayan resolution, the National Historical Commission of the Philippines, stated that there is no record showing that March 8 is the day of the creation of the Municipality. Instead it was March 7, 1998 when the plebiscite was conducted and the residents of the barangays comprising this town ratified and approved the creation of the Municipality of Braulio E. Dujali, Davao, and now Davao del Norte.

In order to follow the intent of Republic Act 8473 otherwise known as, "AN ACT CREATING THE MUNICIPALITY OF BRAULIO E. DUJALI IN THE PROVINCE OF DAVAO AND FOR OTHER PURPOSES" approved on January 30, 1998 but shall acquire corporate existence only upon the ratification of its creation by majority votes in a plebiscite conducted for the said purpose by the Commission on Election which was March 7, 1998, per Certification duly issued by the National Historical Commission of the Philippines dated August 16, 2018, there is a need to declare the 7<sup>th</sup> day of March to be the true and official Foundation day of the Municipality of Braulio E. Dujali, Davao del Norte.

# DECLARING THE 7<sup>TH</sup> DAY OF MARCH AS THE FOUNDATION DAY OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE

Be it enacted by the Sangguniang Bayan of Braulio E. Dujali, that:

**SECTION I**. – March 7, is hereby declared as Foundation Day of the Municipality of Braulio E. Dujali, Davao del Norte.

**SECTION 2**. The Municipal Mayor shall issue an Executive Order setting the activities to highlight the celebration of Foundation Day of the Municipality Braulio E. Dujali, Davao del Norte.

**SECTION 3.** Allocation – The Local Chief Executive shall be given the authority to allocate funds for the purpose from sources available in the office of the Municipal Mayor.

**SECTION 4**. Repealing Clause – that Municipal Ordinance No. 11 S. 99 or any previous ordinance or parts thereof, which are inconsistent to this ordinance are hereby repealed accordingly.

SECTION 5. Effectivity Clause - This ordinance shall take effect immediately upon its approval.
