WHEREAS, Republic Act No. 8435 otherwise known as; "An act prescribing urgent related measures to Modernize the Agriculture and Fisheries sectors of the country in order to enhance their profitability, and prepare said sectors for the challenges of the globalization through an adequate, focused and rational delivery of necessary support services, appropriating funds therefor and for other purposes.", is a welcome development for agriculture and marine based localities;

WHEREAS, farm mechanization plays an important role in achieving these goals as well as attaining sustainable agricultural development;

WHEREAS, the Local Government Unit of Braulio E. Dujali already received three (3) units Mechanized Rice Transplanters from Department of Agriculture-Regional Field Office XI (DA-RFO XI) and is still looking into the possibility of being granted with these mechanized rice weeder in order to further contribute to the reduction of farmers' production costs;

WHEREAS, this LGU advocates Organic Agriculture (OA) that aims to protect the environment from too much degradation due to excessive use of chemicals and other synthetic inputs for rice production;



WHEREAS, with the use of mechanical weeder, the effort of having organic agriculture will be realized through the reduction of labor costs, minimize the application of herbicide and other hazardous farm inputs;

WHEREFORE, on motion of Hon. Nelson C. Baer, duly seconded by all members, it is hereby;


