EXPLANATORY NOTE

The Municipality of Braulio E. Dujali, has been continuously known as one of the peaceful municipalities in the Province of Davao del Norte. This situation can be greatly attributed to the peace-loving Dujalinos and active government functionaries who are doing their best to achieve an environment wherein peace and order is highly valued and experienced by the populace.

The present administration under the able leadership of Atty. Leah Marie A. Moral-Romano, calls for unity and solidarity of all government functionaries not only to promote the further development of the municipality but also to improve the living condition of the Dujaliños by ensuring that peace and order situation of the municipality is firm and stable. One of the approaches to attain this purpose, is the involvement of Purok Officials in the entire municipality as peacekeepers being the frontliners in achieving peace and lasting public order in the grass root level.

The peace and order in every Purok is imperative to the maintenance of peace and order in the barangay in particular and in the municipality in general.

The Purok Officials can best assist, maintain and secure the peace and order in the respective puroks.

The Local Peacekeeping Action Team (LPAT) composed of Purok Officials of the Municipality of Braulio E. Dujali, Davao del Norte, was created by virtue of Executive Order No. 28 s-2016, which is also in line with Section 1165 of Republic Act 7160, which states that, "There is hereby established in every province, city and municipality a local peace and order council pursuant to Executive Order Number Three Hundred Nine (309), as amended, series of 2018", hence this ordinance.

ESTABLISHING THE LOCAL PEACEKEEPING ACTION TEAM (LPAT) OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE

Be it enacted by the Sangguniang Bayan of Braulio E. Dujali, that:

SECTION I. TITLE – This ordinance shall be known as an ordinance establishing the Local Peacekeeping Action Team (LPAT) of the Municipality of Braulio E. Dujali, Davao del Norte.

SECTION 2. SCOPE OF APPLICATION. This ordinance covers the Local Government of Braulio E. Dujali, composed of barangays of Cabayangan, Dujali, Magupising, New Casay and Tanglaw.

SECTION 3. DEFINITION OF TERMS

- a.) Purok is a quasi-government in every barangay.
- b.) Purok Official are composed of the Purok Leaders and Purok kagawads, whether elected or appointed.
- c.) Municipal Peace and Order Council is an organization established and organized by the local government in accordance with Section 116 of Republic Act 7160.
- d.) Local Peacekeeping Action Team (LPAT) refers to an organization composed of Purok Officials duly appointed by the Mayor to assist in the maintenance of peace and order in the municipality.

SECTION 4. COMPOSITION AND MEMBERSHIP – The Local Peacekeeping Action Team (LPAT) shall be composed of Purok Officials of Municipality of Braulio E. Dujali duly appointed by the Mayor as peacekeepers.

SECTION 6. FUNCTIONS, DUTIES AND RESPONSIBLITIES. The members of the Local Peacekeeping Action Team (LPAT) shall:

- a.) Maintain the peace and order in their respective puroks;
- b.) Assist the Local in the implementation of its peace and order plans, programs and activities;
- c.) Coordinate with their respective local peace and order councils of the barangays, municipality, city, province and Philippine National Police, and National agencies or departments concerned;
- d.) Submit quarterly written report to the Office of the Mayor. Non-submission is ground to withhold the grant of year-end cash subsidy;
- e.) Perform such other duties as may be directed by the Mayor.

SECTION 6. GENERAL SUPERVISION. The Mayor shall be the chairman of the Local Peacekeeping Action Team (LPAT) with the general supervision, control and authority over all its members. The Local Peace and Order Council shall assist the governor in providing administrative and technical support to the organization.

SECTION 7. COMMENCEMENT AS MEMBER. Every member may discharge her/his duties and functions as provided in Section 6 only after she/he shall have been appointed by the Municipal Mayor as peacekeeper.

SECTION 8. TERM OF OFFICE. The term of office of a member of the Local Peacekeeping Action Team (LPAT) shall be coterminous to her/his election or appointment into office as Purok official unless earlier removed or suspended in accordance with Section 10.

SECTION 9. SUSPENSION OR REMOVAL. The Mayor suspend or remove a member of the Local Peacekeeping Action Team (LPAT) on any of the following grounds:

- a.) Disloyalty to the Republic of the Philippines;
- b.) Culpable violation of the Constitution;
- c.) Dishonesty, oppression and misconduct;
- d.) Commission of an offense involving moral turpitude;
- e.) Abuse of authority;
- f.) Unauthorized absence for three consecutive months;
- g.) Non-submission of quarterly report;
- h.) Removal or suspension as Purok Official;
- i.) Negligence of duty;
- j.) Violations analogous to the above-enumerated grounds;

SECTION 10. VACANCY. In case of removal or resignation of a member from the Local Peacekeeping Action Team (LPAT), the Mayor shall appoint a replacement from the remaining Purok Officials of the Purok concerned.

SECTION 11. ANNUAL GENERAL MEETING. There shall be an annual general meeting of the members of the Local Peacekeeping Action Team (LPAT), within December 1 to 15 of every year to be held at the Local Government Unit concerned. Purpose of the meeting is to orient members of the plans and programs of the province concerning peace and order and update and upgrade their knowledge and skills in the exercise of their functions.

SECTION 12. QUARTERLY MEETING. The conduct of regular meeting of the Local Peacekeeping Action Team (LPAT) shall be quarterly.

SECTION 13. SPECIAL MEETING. When national or local security is endangered or in times of emergencies or calamities and as often as the need arises, the Mayor call for a special meeting of all the members of the Local Peacekeeping Action Team (LPAT).

SECTION 14. FUNDING SUPPORT. Budgetary requirement and amounts to be incurred in connection with the operation of the Local Peacekeeping Action Team (LPAT), shall be charged to the peace and order funds of the municipality and other funding sources. Supplemental Budget may be provided also for the said purpose.

SECTION 15. GRANT OF SUBSIDY. To complement their efforts in assisting the Local Government Unit of Braulio E. Dujali in the maintenance of the peace and order, every member of the Local Peacekeeping Action Team (LPAT), shall receive Five Hundred Pesos (P500.00) quarterly. The same to be released during the meeting. The same may be upgraded or increased by the Mayor as the need arises and if the budget so warrants subject to the usual budget, accounting and auditing rules and regulations.

SECTION 16. MEDICAL ASSISTANCE. The member of the Local Peacekeeping Action Team (LPAT), shall receive medical assistance in the amount of Five Thousand Pesos (P 5,000.00) upon

presentation of the documents as proof of confinement from the medical hospital. The said assistance shall only be availed of the LPAT member once a year.

SECTION 17. BURIAL ASSISTANCE. In case of death of any member of the Local Peacekeeping Action Team (LPAT), a burial assistance in the amount of Ten Thousand Pesos (P 10,000.00) shall be extended to the immediate family.

SECTION 18. SOURCE OF FUND. The budget allocation for the said medical and burial assistance shall be taken from the operation of Local Peacekeeping Action Team (LPAT) Program under the Locally-funded projects of the Office of the Mayor.

SECTION 19. IMPLEMENTING RULES AND REGULATIONS. Upon approval of this ordinance, the Mayor shall promulgate implementing rules and regulations for its effective and efficient implementation through an executive order.

SECTION 20. SEPARABILITY CLAUSE. If for whatever or any reason any part of this ordinance shall be declared illegal or invalid, all other provisions or parts shall continue to be in full force and effect.

SECTION 21. REPEALING CLAUSE. Municipal Ordinance No. 25 S. 99 is hereby repealed including its appurtenant issuances and directives for its eventual implementation.

SECTION 22. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately after its approval.
