MUNICIPAL ORDINANCE NO. 2019-213

CREATING BRAULIO E. DUJALI OVERSEAS FILIPINO WORKER (OFW) COORDINATING COUNCIL AND PROVIDING FUNDS THEREOF

EXPLANATORY NOTE

Section 3 of Article XIII of the 1987 Philippine Constitution provides that "The State shall afford full protection to labor, local and overseas, organized and unorganized and promote full employment and equality of employment opportunities for all.

Republic Act No. 8042 otherwise known as "The Migrant Workers and Overseas Filipino Act of 1995" recognizes the indispensable role of the government for the protection and promotion of the welfare of migrant workers, their families and overseas Filipino especially those who are in distress.

With that, in order to provide adequate and timely social, economic and legal services to Filipino Migrant Workers, there is a need for an ordinance that will have noble program that will be the venue for the constituents of Braulio E. Dujali, considered to be the home of many Overseas Filipino Workers (OFW) — the modern heroes of the country. As their hard earned monies contributed to financial and economic stability of the LGU and of the country as a

whole, thus, it is paramount that the LGU shall look after their welfare as well as that of their families.

BE IT ENACTED by the Sangguniang Bayan of Braulio E. Dujali, in session assembled that:

SECTION 1: TITLE. This ordinance shall be known as "Ordinance Creating the Braulio E. Dujali OFW Coordinating Council".

SECTION 2: OBJECTIVES. The objective of the Braulio E. Dujali OFW Coordinating Council is to create a one stop OFW center which shall coordinate the initiative of concerned stakeholders in addressing the psycho-social, moral and economic concerns of Dujalinio OFW and their families and to ensure the positive impact of migration on the part of the OFWs, their families and the community.

SECTION 3: DEFINITION OF TERMS. For purposes of this ordinance, the following definition of terms shall apply:

- a. Council refers to the Braulio E. Dujali OFW Coordinating Council.
- b. DOLE refers to the Department of Labor and Employment.
- c. OFW refers to the Overseas Filipino Workers.
- d. OWWA refers to the Overseas Worker Welfare Administration, the agency under DOLE that manages migrant workers welfare fund.
- e. PESO refers to the Public Employment Service Office, a non-fee charging multiemployment service facility or entity established or accredited by DOLE in the Local Government Units, Universities and Colleges pursuant to Republic Act 8759 and its implementing Rules and Regulations.

SECTION 4: The composition of the Braulio E. Dujali OFW Coordinating Council shall be:

- a. Municipal Mayor as Chairperson or duly authorized representative;
- b. Chairperson, SB Committee on Labor and Employment as Vice Chairperson;
- c. OWWA duly authorized representative;
- d. Municipal Planning Development Coordinator;
- e. Municipal Social Welfare and Development Officer;
- f. PESO Manager;
- g. Braulio E. Dujali Police representative;
- h. Liga ng mga Barangay Braulio E. Dujalli (ABC President)
- i. Sangguniang Kabataan Federation President;
- j. Any existing OFW's President organizations in the municipality

SECTION 5: FUNCTIONS AND RESPONSIBILITIES. The Braulio E. Dujali OFW Coordinating Council shall perform functions and shall be responsible:

- a. To create a venue where local investment initiatives geared in utilizing the potentials of OFWs/Filipino Migrants remittance and philanthropic support for the growth and development of the local economy shall be discussed.
- b. To facilitate and recommend the enactment of timely ordinances geared in regulating the legal operations and activities of Overseas Job Recruitment and Placement Agencies

operating within the territorial Jurisdiction of the Municipality of Braulio E. Dujali, Davao del Norte.

- c. To provide a venue wherein common problems, sentiments and aspirations of OFWs/ Migrant Filipinos and their families shall be aired and appreciated for appropriate actions.
- d. To be able to formulate mechanisms for technology transfer wherein the skills and technologies acquired by OFWs/Filipino migrants in their host countries shall be learned and acquired by the local manpower.
- e. To provide the venue where specific incentives, assistances, privileges and specific services for OFWs/Filipino migrants and their families shall be discussed and carefully evaluated from time to time for the purpose of acknowledging their valuable contribution to nation building.
- f. To facilitate the declaration of a Municipal-wide OFW / Filipino Migrants Celebration week, cultural activities, bazaars, program, symposiums, contest, awarding ceremonies and ensure that OFW / Filipino Balikbayan homecoming shall be observed.
- g. To create a condition wherein Organizations of OFW's/Filipino Migrants and their families shall be strengthened and recognized, provided assistance and maximized as potent component and reliable partner of the LGU in pursuit of a more responsive and progress oriented governance.
- h. To be able to adopt specific safety nets, tactical and strategic programs for OFW's/Migrant Filipinos and their family dependents in the local level in fulfillment to the vision and mission of the national government.

SECTION 6: OFFICE. The Braulio E. Dujali OFW Coordinating Council shall hold office at the Public Employment Service Office with an OFW Coordinator as focal person to be appointed by the Municipal Mayor and a secretariat duly constituted by the council to take charge of its day to day activities.

SECTION 7: IMPLEMENTING RULES AND REGULATIONS. The Municipal Mayor upon recommendation of the Braulio E. Dujali OFW Coordinating Council shall formulate Implementing Rules and Regulations necessary for the efficient and effective implementation of this ordinance.

SECTION 8: FUNDS. The fund of the Braulio E. Dujali OFW Coordinating Council shall be derived from the funds raised as well as funds received from the gratuitous donations by the Council and the counterpart funds of the Braulio E. Dujali E. Government in the amount of not less than Fifty Thousand Pesos (P 50,000.00) annually.

SECTION 9: SEPARABILITY CLAUSE. If for any reason, any section or provision of this ordinance shall be held unconstitutional or involved in any court of competent jurisdiction such judgment shall not affect or impair the other provisions or parts thereof which shall continue to be in full force and effect.

SECTION 10: REPEALING CLAUSE. All ordinances, rules and regulation inconsistent with this ordinance are hereby repealed or modified accordingly.

SECTION 11: EFFECTIVITY This ordinance shall take effect immediately upon approval.
