MUNICIPAL ORDINANCE NO. 2019-214

GRANTING RECOGNITION AND INCENTIVES TO EVERY DUJALIÑO WHO WILL BECOME TOPNOTCHER IN NATIONAL BOARD/BAR EXAMINATION

EXPLANATORY NOTE

This is to recognize the efforts exerted by the successful board/bar examinees who landed on top ten during their respective board/bar exams and inspiring others to strive for excellence in the field of education.

Be it Ordained by the Sangguniang Bayan of Municipality of Braulio E. Dujali that:

SECTION 1. TITLE. This Ordinance shall be known as GRANTING RECOGNITION AND INCENTIVES TO EVERY DUJALIÑO WHO WILL BECOME TOPNOTCHER IN NATIONAL BOARD/BAR EXAMINATION.

SECTION 2. DECLARATION OF POLICY. The Municipality of Braulio E. Dujali hereby institutionalizes the program of granting recognition and incentives to Dujaliños who become a topnotchers in the National Board/Bar Examinations.

SECTION 3. SCOPE AND COVERAGE. This Ordinance shall include all individuals who brought honor and prestige to the Municipality of Braulio E. Dujali for having landed among the topnotchers during board/bar examinations given by the Professional Regulatory Commission and the Supreme Court of the Philippines.

SECTION 4. DEFINITION OF TERMS. The terms as used in this ordinance shall be defined as follows:

1. Topnotcher - a Dujaliño who ranked 1 up to 10 in the board/bar examination conducted by the authorized government agency as stated in Section 4, number 2 of this ordinance.
2. Board/Bar Examination - given by the Professional Regulatory Commission and the Supreme Court of the Philippines.
3. Dujaliño – the term shall refer to an individual who is residing in the Municipality of Braulio E. Dujali and has finished his/her elementary and secondary education in any schools in the locality.

SECTION 5. AMOUNT OF INCENTIVES. The topnotcher, upon verification, shall receive incentives and a plaque of recognition based on the following category:

SECTION 6. VERIFICATION COMMITTEE – There shall be created a verification committee to be composed of the following:

SECTION 7. FUNCTION/ROLE/RESPONSIBILITY OF THE VERIFICATION COMMITTEE. The function, role and responsibility of the verification committee shall make an assessment as to the authenticity of documents required and shall thereafter make a recommendation for the release of said incentive.

SECTION 8. REQUIREMENTS. For an individual to be entitled of the incentive shall submit the following:

- Authenticated photocopy of Diploma;
- Certification from the school he/she has graduated;
- Authenticated photocopy of the Board/Bar examination result;
- A page of a newspaper showing his/her name among the successful examinees;
- A printed screenshot of list of successful examinees showing his/her name released through the internet.
- Barangay Certification as to residency;

SECTION 9. APPROPRIATIONS. An amount of Thirty Thousand Pesos (P30,000.00) shall be appropriated annually from the General Fund.


SECTION 10. SEPARABILITY CLAUSE. If for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid by any competent court, such judgment or action shall not affect or impair the other sections or provision thereof.

SECTION 11. REPEALING CLAUSE. All ordinances, executive orders, rules and regulations, or part thereof, in conflict or inconsistent with any provisions of this Ordinance are hereby repealed.


SECTION 12. EFFECTIVITY. This Ordinance shall take effect upon approval.


