MUNICIPAL ORDINANCE NO. 2019-215

PROVIDING CASH INCENTIVES TO ELDERLY INDIVIDUAL WHO REACHES 86 YEARS OLD AND BEYOND IN THE MUNICIPALITY BRAULIO E. DUJALI, DAVAO DEL NORTE AND ALLOCATING FUNDS FOR THE IMPLEMENTATION THEREOF

EXPLANATORY NOTE

This ordinance was created in order to give full support to the improvement of the total well-being of the elderly and their full participation in society, considering that senior citizens are integral part of Philippine society as stated in RA 9994, otherwise known as the Expanded Senior Citizens Act of 2010.

BE IT ORDAINED by the Sangguniang Bayan of Municipality of Braulio E. Dujali that:

SECTION 1. TITLE. This Ordinance shall be known as "PROVIDING CASH INCENTIVES TO ELDERLY INDIVIDUAL WHO REACHES 86 YEARS OLD AND BEYOND IN THE MUNICIPALITY BRAULIO E. DUJALI, DAVAO DEL NORTE AND ALLOCATING FUNDS FOR THE IMPLEMENTATION THEREOF".

SECTION 2. DECLARATION OF POLICY. As provided in the Constitution of the Republic of the Philippines, it is declared policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living and improved quality of life.

SECTION 3. SCOPE AND COVERAGE. This Ordinance shall include all elderly individuals who reaches 86 years old and beyond and a bonafide resident of the Municipality of Braulio E. Dujali who submits himself/herself all the required documents.

SECTION 4. DEFINITION OF TERMS. Terms found in this ordinance shall be defined as follows:

1. *ELDERLY INDIVIDUAL - an individual who is a resident of the Municipality of Braulio E. Dujali who reaches 86 years old and beyond.*
2. *REQUIRED DOCUMENTS -any proof of birth, and proof of residency in the Municipality of Braulio E. Dujali.*

SECTION 5. QUALIFICATIONS. An elderly is considered qualified and if he or she:

- a. Must be a member of the Senior Citizen Association of this municipality.
- b. Must be a resident of this municipality for not less than 10 years.

SECTION 6. VERIFICATION OF BENEFICIARIES. All qualified elders shall be verified by presenting the following primary requirements:

- *Senior Citizen's Identification (ID) Card issued by the head of the Senior Citizen's Affairs (OSCA) indicating the date of birth;*
- *Authenticated Birth Certificate (Registered before 2016)*

In the absence of the abovementioned requirements, any two (2) of the following secondary documents may also be accepted as valid proof:

- *Government issued identification cards such as, Driver's License, SSS ID, GSIS ID, Voters ID, Postal ID, PRC ID, Passport and etc. showing citizenship and date of birth as a reference point.*
- *Marriage Certificate of the elderly issued by the Philippine Statistics Authority of the Local Civil Registrar;*
- *Birth Certificate of Children borne by/of the elderly issued by the Philippine Statistics Authority of the Local Civil Registrar;*
- *Affidavits executed by at least two (2) disinterested persons should be at least 80 years old and above with personal knowledge of the elder's actual age or date of birth;*
- *Old School or Employment Records showing date of birth of an elder;*
- *Baptismal and or Confirmation Records of an elder certified by the Parish Church and other religious denomination;*

- *Medical and or Dental Examination issued by the government/private doctors or dentist showing date of birth;*
- *Other related documents i.e. certification from National Commission on Muslim Filipinos (NCMP)/National Commission on Indigenous People (NCIP); AFPSLAI, AMWSLAI, Veterans, Passport and etc. showing date of birth;*

SECTION 7. AMOUNT OF INCENTIVES. The elderly individual, upon verification, shall be entitled to receive cash incentives based on the following category:

SECTION 8. MANNER OF AVAILMENT – The elderly individual can avail the cash incentive only once of each age bracket/category.

SECTION 9. APPROPRIATIONS. An annual appropriation shall be allocated in the budget to effectively carry out this ordinance.


SECTION 10. SEPARABILITY CLAUSE. If for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid by any competent court, such judgment or action shall not affect or impair the other sections or provision thereof.

SECTION 11. REPEALING CLAUSE. All ordinances, executive orders, rules and regulations, or part thereof, in conflict with, or inconsistent with any provisions of this Ordinance are hereby repealed.


SECTION 12. EFFECTIVITY. This Ordinance shall take effect upon the approval.


