RETITLING OF POSITIONS IN THE PLANTILLA OF PERSONNEL OF THIS LOCAL GOVERNMENT UNIT PURSUANT TO CIVIL SERVICE COMMISSION MEMORANDUM CIRCULAR NO. 12, S. 2011 RE: REVISED GUIDELINES ON THE DETERMINATION OF POSITIONS IN THE LOCAL GOVERNMENT UNITS AS PRIMARILY CONFIDENTIAL

BE IT ENACTED by the Sangguniang Bayan that:

SECTION 1. There is hereby enacted an ordinance retitling certain positions in the Plantilla of Personnel under the Office of the Municipal Mayor of the Local Government Unit of Braulio E. Dujali, Davao del Norte pursuant to Civil Service Commission Memorandum Circular No. 12, series 2011, re: Revised guidelines on the determination of positions in the Local Government Units as primarily confidential, in order to reflect their actual duties and responsibilities.


