WHEREAS, the Resolution No. 1 series of 2019 embodying the Supplemental Annual Investment Program (SAIP) No. 1 for Calendar Year 2019 of Barangay Magupising was submitted to this Honorable Council and was later endorsed to the Committee on Finance, Budget and Appropriations for review;

WHEREAS, the committee found out that source of funds came from 5% calamity fund in the amount of P 60,139.00 and from the 20% Development Fund Years 2016 and 2018 amounting to P410,359.20 which was re-appropriated to purchase one (1) unit rescue vehicle under the 20% Development Fund in the amount of P470,499.19;

WHEREAS, and that savings from 5% calamity fund could not be used to fund the other classification but shall be reverted into General Fund and be appropriated to social services after 5 years;
