- e) Property No. 241-038 - Tanglaw



WHEREAS, the repairs, maintenance and other necessary expenses relative to the operation and usage of the vehicle shall be shouldered by the respective barangay government;

NOW THEREFORE, on motion of Hon. Ricky T. Delco, duly seconded by majority of members present, it is hereby;


