DUJALI, REPRESENTED BY THE LOCAL CHIEF EXECUTIVE AND DR. CHERRY T. DEMA-ALA, MUNICIPAL HEALTH OFFICER AND DAVAO REGIONAL MEDICAL CENTER, REPRESENTED BY DR. BRYAN O. DALID, MEDICAL CHIEF II, DR. JULMIN T. TAPSIRUL II, CHIEF TRAINING OFFICER AND DR. SUZETTE H. SOLIS, DEPARTMENT CHAIR IN CONNECTION WITH THE DEPARTMENT OF FAMILY AND COMMUNITY MEDICINE RESIDENCY TRAINING PROGRAM.

WHEREAS, letter dated August 22, 2019 of Atty. Leah Marie Moral-Romano, Municipal Mayor addressed to Vice Mayor Donna Mae Baldonado-Bernadas, Ed.D thru the Sangguniang Bayan, requesting for the passage of resolution giving authority to the Local Chief Executive on behalf of this municipality to enter into Memorandum of Agreement by and between the Rural Health Unit of Braulio E. Dujali, represented by the Local Chief Executive and Dr. Cherry T. Dema-ala, Municipal Health Office and Davao Regional Medical Center, Represented by Dr. Bryan O. Dalid, Medical Chief II, Dr. Julmin T. Tapsirul II, Chief Training Officer and Dr. Suzette H. Solis, Department Chair in connection with the Department of family and Community Medicine Residency Training Program, was forwarded to this level and later referred to the committee, for study;

WHEREAS, the content of the said MOA is as follows;

### MEMORANDUM OF AGREEMENT

### **KNOWN ALL MEN BY THESE PRESENTS:**

This agreement made and entered into and executed by and between:

The <u>Rural Health Unit of Braulio E. Dujali</u> herein represented by Hon. Atty. Leah Marie Moral-Romano, Municipal Mayor of Braulio E. Dujali, Dr. Cherry T. Demaala, MD, Municipal Health Officer, herein after referred to as <u>RHU-Braulio E. Dujali</u>.

and

The <u>Davao Regional Medical Center</u>, a tertiary government hospital duly organized under the laws of the Philippines and officially recognized by the Department of Health, Association of Philippine Medical Colleges, Inc. and with a <u>Department of Family and Community Medicine</u> Residency Training Program duly accredited by the <u>Philippine Academy of Family Physicians</u>, herein represented by <u>Dr. Bryan O. Dalid</u>, Medical Center Chief II, <u>Dr. Suzette H. Solis</u>, Department Chairperson and <u>Dr. Marjorie A. Pelegrino</u>, Department Training Officer herein after referred to as <u>DRMC</u>.

### WITNESSETH

WHEREAS, the Department of Health, cognizant of its responsibility of improving and maintaining quality of people's lives and aware of the role in the development and manpower that is responsive to health needs, has committed to offer its hospital and community health resources for learning and training experiences (Department of Health Administrative Order No. 87, s. 1980).

WHEREAS, Article II Sec. 20 of the Philippines Constitution mandates that the State recognizes the indispensable role of the private sector, encourages private enterprises and provide incentives to investments:

WHEREAS, Article II Sec. 23 of the Philippines Constitution mandates that the State shall encourage non-government community-based or sectoral organizations that promote the welfare of the nations;

WHEREAS, there is a felt need to improve the quality of health care;

WHEREAS, such quality care can be improved by strengthening its Post Graduate Internship training program through a collaborative effort between government and non-government entities in the spirit of networking;

WHEREAS, the Association of Philippine Medical Colleges, Inc., through its Committee on Accreditation recommends that there is a need for the two accredited training hospitals to pool their resources together so as to maximize the benefits for their Post Graduate Interns and eventually their patients;

Now, therefore, for and in consideration of the above premises and mutual covenant, the parties heretofore agree as follows:

- That the concerned parties namely: RHU-Braulio E. Dujali and <u>DRMC</u>, shall enter into a contract so as to form a linkage for the purpose of Post Graduate Internship Training Program in Community Medicine;
- 2. That <u>Community Medicine</u> Interns from DRMC shall rotate for Two (2) Months in <u>RHU-Braulio E. Dujali</u>;
- 3. That Post Graduate Internship (PGI) rotating from the member hospital shall abide and be governed by the rules and regulations of the municipal health unit;
- 4. That both parties shall be committed to support and strengthen research capabilities;
- That this agreement entered into by and between RHU- Braulio E. Dujali and <u>DRMC</u> shall be binding to all parties concerned;
- 6. That the Association of Philippine Medical Colleges Inc. is committed to assist in the formulation, implementation, monitoring and evaluation of the training programs;
- 7. That the LGU of Braulio E. Dujali shall provide the transportation, accommodation and security of the PGI and Resident physician rotating in the community;
- That this MOA is valid only for a period of three years and renewable annually. This may
  be terminated upon mutual consent of the parties. This shall take effect upon approval
  of the Secretary of Health or his duly authorized representative;
- 9. That the term of this MOA is from September 9, 2019 up to December 31, 2019.
