FOREWORD

The purpose of passing this ordinance is to prevent drowning accidents among young children. Records of the World Health Organization show that the Municipality of Braulio E. Dujali in the Province of Davao del Norte is among the many localities in the region that has a greater number in drowning incidents and victims mostly are very young children.

MUNICIPAL ORDINANCE NO. 2020-223

REQUIRING ANY PERSON WHO INTENDS TO UNDERTAKE OR MAY HAVE UNDERTAKEN OPEN GROUND DIGGING TO INSTALL FENCE/BARRIERS WITHIN THE PERIMETER AND IMPOSING FINES AND PENALTIES TO VIOLATORS HEREOF

BE IT ENACTED by the Sangguniang Bayan in session, duly assembled that:

SECTION 1. Any person who intends to undertake or may have undertaken open ground digging shall properly inform the Barangay concerned and shall also install fence/barriers within the perimeter where digging is located.

SECTION 2. Any person who intends to dig or who have dug on the ground for purposes that include but are not limited to the following:


- 1) Dug well for domestic use
- 2) Septic tank
- 3) Compost pit
- 4) Or any similar ground activity that may result to accumulation of water which would likely drown or harm young children, shall be required to secure the ground hole either by constructing a fence or a barrier of not less than 3 feet in height which is good enough to keep young children from falling and in worse case, drowning.

SECTION 3. The Office of the Municipal Health Officer, the Office of the Municipal Engineer and the Sanitary Inspector of each Barangay shall conduct a periodic inspection in all households of this municipality and shall make a written report as to their compliance, to the Office of the Mayor and furnishing the same to the Sangguniang Bayan.


SECTION 4. PENALTY CLAUSE. Failure to comply Section 1 and Section 2 of this ordinance shall subject the violator hereof of a fine in the amount of P1,000.00 to be paid at the Municipal Treasurer's Office who shall likewise issue a corresponding official receipt.

SECTION 5. EFFECTIVITY. This ordinance shall take effect upon approval.


