WHEREAS, it shall serve as a guide in the implementation of programs/projects/activities that will support to the conduct of a holistic Anti-Crime approach;



WHEREAS, all programs and projects contained therein are necessary in the implementation and maintenance of Peace and Order within the Municipality;
