MUNICIPAL ORDINANCE NO. 46 S. 2002

AN ORDINANCE APPROVING THE RECLASSIFICATION OF LOT NO 400
SGS 4297-D AND LOT NO. 1500-J, LOCATED RESPECTIVELY AT SITIO
BUGTONG, TALISAY, DUJALI AND BARANGAY MAGUPISING, THIS
MUNICIPALITY FROM AGRICULTURAL TO RESIDENTIAL PURPOSES.

WHEREAS, Section 20 of RA 7160 provides that, a city or municipality may, through an ordinance passed by the sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial or industrial purposes, as determined by the sanggunian concerned. Provided that such reclassification shall be limited to the prescribed percentage of the total agricultural land area at the time of the passage of the ordinance, hence


BE IT ENACTED by the Sanggunian that:

SECTION 1. Lot No. 400-SGS-4297-D and Lot No. 1500-J, located respectively at Sitio Bugtong Talisay, Dujali and Barangay Magupising, this municipality are hereby reclassified of their uses from agricultural to residential.

SECTION 2. This ordinance shall take effect upon approval.
