WHEREAS, offices that have kept skeleton force had identified and required certain employees to report to office on a regular basis especially those that are fielded to respond or attend to COVID related activities;


WHEREAS, this body finds it fitting that their efforts and the risk/face of getting infected be atleast compensated, hence;

WHEREFORE, on motion of Hon. Yasmin V. Campion and duly seconded by all members present, it is hereby;


