**GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE TO GIVE SPECIAL RISK ALLOWANCE (SRA) TO BARANGAY HEALTH WORKERS (BHWS), ALLIED HEALTH PROVIDERS INCLUDING THOSE ASSIGNED IN THE HEALTH CARE FACILITIES OF THIS LGU WHO ARE DIRECTLY IN CONTACT WITH COVID-19 PATIENTS, PERSONS UNDER MONITORING (PUM) AND PERSONS UNDER INVESTIGATION (PUI) IN THE AMOUNT THAT IS EQUIVALENT TO 25% OF THEIR BASIC MONTHLY PAY**


**WHEREAS**, in support to all intents and purpose of the President as clearly prescribed in the said Administrative Order, this body;
