REQUESTING THE LOCAL ZONING BOARD OF ADJUSTMENT AND APPEALS (LZBAA) FOR THE POSSIBLE EXCEPTION OF A 428 SQ. M. LOT, NO. 3, BLOCK 21, SWO-41748, EMBRACED BY OCT C-4148, SITUATED AT BARANGAY DUJALI HOMESITE SUBDIVISION, THIS MUNICIPALITY, THUS ALLOWING IT TO BE USED FOR INFRA-UTILITIES

WHEREAS, this honorable body was in receipt of an endorsement from Hon. Vice Mayor Donna Mae B. Bernadas, Ed.D thru Ms. Juliet E. Daanton, Secretary to the Sanggunian, of an application for reclassification of Lot with specifications shown in the foregoing by Ms. Ella Alamillo-Tautho from its present use as residential to infra-utilities;

WHEREAS, the said lot is wherein a multi-national company intends to erect their telecommunication tower of which this body believes it to be an added proof of economic progress of this locality;

WHEREAS, Article VIII, Section 32 (2) of this municipality's Land Use Plan for CY 2013-2022 states that "Exceptions:

- 1) The exception will not adversely affect the proposed projects and shall support economic based activities/provide livelihood, vital community services and facilities while at the same time posing no adverse effect on the zone/community;
- 2) The exception will not affect the appropriate use of adjoining property in the same district;
- 3) The exception will not alter the essential character and general purpose of the district where the exception sought is located”.


WHEREAS, this body therefore believes that the above mentioned exceptions have offered a leeway for the proposed project to push through;
