WHEREAS, the Supplemental Budget No. 6 for CY 2020 of the Municipality of Braulio E. Dujali, Davao del Norte amounting to THREE MILLION THREE HUNDRED SEVENTY THREE THOUSAND FIVE HUNDRED FIVE PESOS AND NINETY NINE CENTAVOS (P 3,373,505.99) was received by this honorable body, for consideration;

WHEREAS, in the MDC Resolution No. 13 series of 2020, the amount of P30,000.00 was among those declared as savings, while in Supplemental Budget No. 6 CY 2020, the said amount was identified as new source, which is actually correct, it being an incentive given to the municipality for having chosen as an Adolescent Friendly Municipality;

WHEREAS, MDC Resolution No. 13 further becomes inconsistent with Supplemental Budget No. 6 CY 2020 because the total amount of savings in the former should have been P3,343,505.99, only;



WHEREFORE, on motion of Hon. Yasmin V. Campion, duly seconded by all members present, it is hereby;


